C-27J JCA Schoolhouse Opening Marks Training Transition to Robins Air Force Base

WACO, Texas – Dec. 9, 2009 – The C-27J JCA Team, led by L-3 Communications, announced today that it will celebrate the opening of a new training center for the C-27J Joint Cargo Aircraft (JCA) Program on Dec. 9, 2009, at Robins Air Force Base, Ga.

The C-27J JCA Team recently transitioned its schoolhouse training operations from an interim site at L-3's Waco, Texas integration center to the location at Warner Robins. Initial pilot and load master training was conducted by Global Mobility Aircraft Systems (GMAS) and L-3 Link Simulation and Training.

The new C-27J JCA schoolhouse facility includes space for classroom instruction, a full-fidelity operational flight trainer and a Fuselage Trainer (FuT). The first C-27J JCA to be used for training arrived on Sept. 9, 2009. The FuT will be ready for training by July 2010, while the flight trainer is scheduled for installation in 2011.

"The commitment of the entire Middle Georgia community to this partnership has been important in its success," said James Burkhardt, president of L-3's Platform Integration division. "The training center becoming operational is an important milestone as we prepare C-27J JCA crews for testing and deployment."

During the first two years of instruction at the C-27J schoolhouse, student throughput is projected to reach 48 students, split equally between pilots and loadmasters. The schoolhouse is expected to reach a peak student throughput of 144 students in the fifth year of the program. Pilot, loadmaster and instructor recurrent training is anticipated to increase the number of students by 100 during the fifth year.

The schoolhouse was built under a government-private partnership established among L-3, the State of Georgia Department of Defense, and the Warner Robins Air Logistics Center. The C-27J JCA training center's \$1.8 million construction was supported by \$300,000 from the state of Georgia; \$125,000 from

both the City of Warner Robins and the Houston County Development Authority; and \$50,000 from the Macon-Bibb Development Authority.

The C-27J JCA industry team is led by L-3 and includes aircraft manufacturer Alenia Aeronautica and GMAS.
